Ruling

1. On the condition that the Petitioner deposits a sum of 10,000,000 Won as collateral for the Respondent:

A. Respondent shall not produce, use, sell, lend, advertise, import or export the

items shown in the Exhibit until August 20, 2005. Respondent also shall not make a contract of transfer or loan on such items until August 20, 2005.

B. Respondent is to dispossess finished and semi-finished products stipulated in the Exhibit and machine equipments, such as molding machinery, to manufacture the finished and semi-finished products. Respondent is then to ask [a court-appointed] Bailiff to have such products in his/her custody.

2. Bailiff is to publicly announce the intent of the above decision in an appropriate manner.
3. Respondent is to bear the cost of this petition.

Point of Petition

It is the same with the above ruling other than the condition that there is a collateral offering.

Ground

The court finds a [reasonable] ground with the petition on its preservative rights and the necessity of its preservation. Hereby the court makes its ruling [written above] on the condition that Petitioner deposits a sum of 10,000,000 Won as collateral for Respondent.
